RESOLUTION LEVYING A TAX RATE

BE IT RESOLVED, by the Commissioners court of Sutton County, Texas, that on this 2nd day of September 2021, a motion was made by Commissioner Fred Perez and seconded by Commissioner Bob Brockman to increase the property tax rate to \$0.12564.

RESOLVED BE IT FURTHER that the undersigned do hereby vote to levy or adopt the tax rate for Sutton County FMFC Fund for the 2021 tax year at \$0.12564 for the purpose of maintenance and operation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERTAION THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY .002639 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON \$100,000 HOME BY APPROXIMATELY \$27,814.959974.

The Tax Assessor-Collector is hereby authorized to assess and collect the taxes of the County of Sutton, State of Texas, on this 2nd day of September, 2021.


RESOLUTION LEVYING A TAX RATE

BE IT RESOLVED, by the Commissioners court of Sutton County, Texas, that on this 2nd day of September 2021, a motion was made by Commissioner Lee Bloodworth and seconded by Commissioner Carl Teaff to increase the property tax rate to \$0.567221.

RESOLVED BE IT FURTHER that the undersigned do hereby vote to levy or adopt the tax rate for Sutton County General Fund for the 2021 tax year at \$0.567221 for the purpose of maintenance and operation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERTAION THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY .031493 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON \$100,000 HOME BY APPROXIMATELY \$124,256.83977.

The tax Assessor-Collector is hereby authorized to assess and collect the taxes of the County of Sutton, State of Texas, on this 2nd day of September, 2021.
